# e. VEHICLE EMERGENCY EQUIPMENT INSTALLATION APPROVAL

Steve Hoctor motioned to approve the contract with Drive Customs in San Luis Obispo for lights and the radio to be professionally installed in the new Trailblazer, in the amount of \$5,399.98 to be paid out of Reserves, Mike Garner seconded. The contract was approved by a vote of 6/0.
