#### 9. <u>NEW BUSINESS</u>

#### a. FRONT GATE AND CLUBHOUSE GENERATOR BID APPROVAL

The front gate and clubhouse generators are due to be replaced to be paid for out of Reserves. Management has solicited bids from numerous generator installation companies and electricians. All Tech has submitted a detailed bid for the installation of two (2) new generators at the gate and clubhouse. Management is recommending that the Board approve the contract with All Tech and move forward immediately.

#### b. APPROVAL OF CONTRACT FOR SLO CIVIL DESIGN, LLC

Richard Burde, Principal Civil Engineer, of SLO Civil Design is conducting a detailed evaluation of the areas of concern on the Association greenbelts that have erosion issues. The Board must approve the contract, with costs to be paid out of the Reserves as budgeted.

#### c. CLUBHOUSE OUTDOOR CURTAIN REPLACEMENT

The Clubhouse outdoor patio curtains are due to be replaced to be paid out of Reserves. Shoreline Awnings and S & J Upholstery have put in bids for the replacement of these curtains. Management is recommending that the Board approve the contract with Shoreline Awning for this replacement
